OVERVIEW

I have built my practice at the convergence of international dispute resolution and the digital economy. 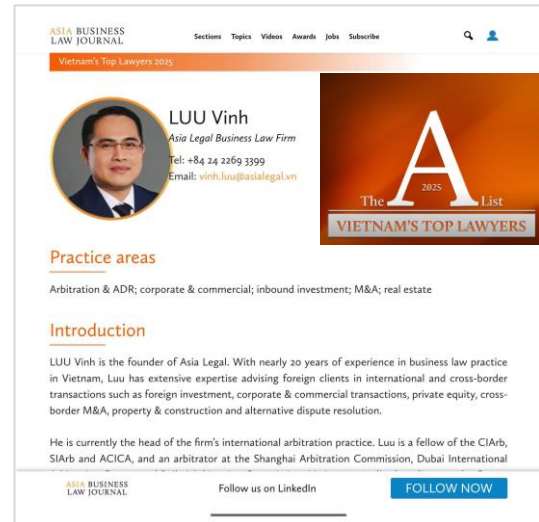
